THEORY

The choice of the city should be clearly indicated in the appropriate box in the application form. However, CPSP reserves the right to delete a particular centre on the basis of logistic reasons.

ORAL / CLINICAL

The College can hold oral/practical/clinical examination in one or more cities of the country depending upon the number of candidates eligible to take this examination and logistic facilities available in that city irrespective of the venue at which a candidate appeared in theory examination. Exact Venue of Oral/Clinical/Practical examination will be communicated after the theory examination.
