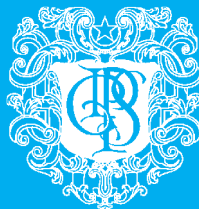

3 EXAMINATION FEE SR. 1350/- PLUS SR 650/- = SR. 2000/-

Examination fee as mentioned above is to be paid as under:

- Deposit SR 1350/- in Alawwal Bank (A/CNo. 037083953004) in favour of Saudi Commission for Health Specialties / College of Physicians and Surgeons, Pakistan and obtain deposit receipt.
- Deposit SR 650/- in National Commercial Bank (A/C No. 20159007001306)
Submit above two original deposit slips in Cpsp Head Office Karachi.
- If the application is submitted after **July 01, 2019 (Fresh / Repeater Candidates)** another SR 500/- as late fee in Alawwal Bank (A/C No. 037083953004) must be deposited.

4 REFUND OF FEE

Seventy five percent of the examination fee shall be refunded to the candidate after deduction of 25% as processing fee subject to following:

- Receipt of application for withdrawal from the examination on or before the specified date.
- Rejection of the application by CPSP on account of ineligibility deficient documents.
- While applying for REFUND, candidate must write his / her NAME, CENTRE, SUBJECT and BANK RECEIPT NUMBER.

In all other cases the fee paid for a particular examination will not be refunded or carried over to next examination in case of withdrawal after specified date, absence/exclusion from the examination for any reason.
